FORENSIC EVIDENCE EXAMS

Specially trained SAFE (sexual assault forensic examiner) or SANE (sexual assault nurse examiner) nurses at the hospital emergency room can perform forensic evidence exams within 96 hours of an assault. Sexually transmitted infections (STIs), pregnancy, and treatment of injuries can also be addressed.

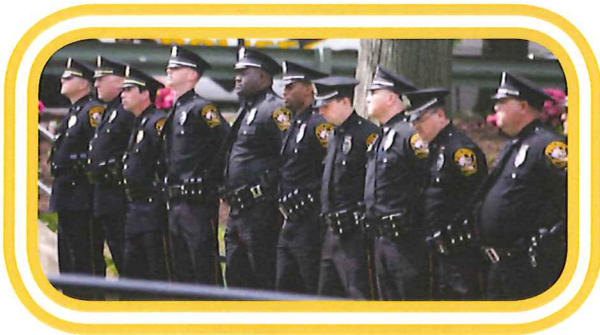
